<u>THE WARWICKSHIRE COUNTY COUNCIL ((DALEHOUSE LANE, KENILWORTH) (C32</u> <u>STONELEIGH ROAD AND BIRMINGHAM ROAD, STONELEIGH))</u> (40 MPH AND 50 MPH SPEED LIMIT) ORDER 2022

The Warwickshire County Council in exercise of its powers under section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, hereby make the following Order: -

1. In this Order:

"Nosing" means a paved piece of land approximately triangular in shape which is marked with road markings of a type shown in diagram 1042 in Part 6 of Schedule 9 to the Traffic Signs Regulations and General Directions 2016

- 2. Save as provided in Article 4 below, no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road described in the Schedule 1 to this Order.
- 3. Save as provided in Article 4 below, no person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road described in the Schedule 2 to this Order.
- 4. The provisions of Articles 2 and 3 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
- This Order may be cited as "The Warwickshire County Council ((Dalehouse Lane, Kenilworth)(C32 Stoneleigh Road and Birmingham Road, Stoneleigh))(40mph and 50 mph Speed Limit) Order 2022" and shall come into operation on the of Two Thousand and Twenty two.

SCHEDULE 1 (40 MPH)

Dalehouse Lane, Kenilworth

(i) From its junction with the C32 Stoneleigh Road in a south-westerly direction for a distance of 630 metres.

SCHEDULE 2 (50 MPH)

Birmingham Road/ C32 Stoneleigh Road

(i) From a point 39 metres northwest of the centre of its junction with Hall Close in the in the village of Stoneleigh, in a north westerly direction, to the Coventry City Council / Warwickshire County Council boundary line, a distance of 2100 metres (including the island over the A46 and island with Dalehouse Lane junction).

A46 Slip Roads – Island Junction with C32 Stoneleigh Road (slip roads outside of National Highways boundary)

(ii) A46 northbound on slip (From the C32 onto the A46)

From the tip of the Nosing on the A46 north bound on-slip, for a distance of 21.5m in a north easterly direction

(iii) A46 southbound on slip (From the C32 onto the A46)

From the tip of the Nosing on to the A46 south bound on-slip, for a distance of 14m in a south westerly direction.

(iv) A46 northbound off slip (From A46 into the C32)

From the tip of the Nosing on the A46 north bound off-slip to a distance of 11.5m in a south westerly direction

(v) A46 southbound off slip (From A46 onto the C32)

From the tip of the Nosing on the A46 south bound off-slip, for a distance of 24.5m in a north easterly direction

Unnamed road (opposite Dalehouse Lane (Northeast end) off the roundabout junction with C32 Stoneleigh Road

(vi) From the roundabout junction with Dalehouse Lane and the C32 Stoneleigh Road in a north-easterly direction for a distance of 14.5 metres on the unnamed road.
