- ii. Eastbound on B4114 Birmingham Road, Right turn prohibited into B4117 High Street.
- iii. Southbound on B4117 High Street, Right turn prohibited into B4114 Birmingham Road.

iv. Westbound on B4114 Blythe Road, Right turn prohibited into B4117 High Street.
