**HIGHWAYS ACT 1980 – SECTION 90A and 90G**

**PROPOSED PEDESTRIAN ZEBRA/CYCLIST PARALLEL CROSSINGS - GUYS CROSS PARK ROAD, WARWICK, AND ROWAN DRIVE, WARWICK**

Warwickshire County Council hereby gives notice of its intention to install 2 No. parallel pedestrian and cycle crossings on Guys Cross Park Road, Warwick, cycle/pedestrian priority crossings on Rowan Drive, Warwick, and Station Avenue, Warwick, to upgrade the existing puffin crossing on the A429 Coventry Road to a toucan crossing, and to provide a new toucan crossing on the A429 Coventry Road as part of a highways improvement and cycling infrastructure scheme along the A429 Coventry Road, Warwick, and adjoining streets as described in Schedule 1 below.

Warwickshire County Council further proposes, under sections 90A and 90G of the Highways Act 1980, to install the raised tables/build out as described in more detail in Schedule 2 below, in connection with the proposed crossings and highway improvements.

**SCHEDULE 1**

**Locations of Pedestrian Zebra/Cyclist Parallel Crossings**

Guys Cross Park Road, Warwick – approximately 15 metres west of its southern junction with the A429 Coventry Road

Guys Cross Park Road, Warwick – approximately 15 metres west of its northern junction with the A429 Coventry Road

**Location of Cycle/Pedestrian Priority Crossings**

Rowan Drive, Warwick – approximately 5 metres west of its junction with the A429 Coventry Road

Station Avenue, Warwick – approximately 10 metres east of its junction with the A429 Coventry Road

**Location of Toucan Crossings**

A429 Coventry Road – existing puffin crossing to be upgraded, approximately 80 metres north of the junction with Station Road

A429 Coventry Road – approximately 10 metres north of its junction with Lakin Road

## **SCHEDULE 2**

### **Locations of raised table road humps**

The Paddocks – located 15m west of its junction with A429 Coventry Road (full carriageway width, approximately 10m length, 75mm height)

Station Avenue – located 10m east of its junction with A429 Coventry Road (full carriageway width, approximately 10m length, 75mm height)

Guys Cross Park Road – located on its entry approximately 15 metres west of its southern junction with A429 Coventry Road- (full carriageway width, approximately 8.2m length, 75mm height)

Rowan Drive - located 5m west of its junction with A429 Coventry Road (full carriageway width, approximately 10m length, 75mm height)

### **Location of Proposed Footway Build Out/Road Narrowing**

Guys Street - located opposite property numbers 68-72 Guys Street approximately 12m length, 2.5m build out, full kerb height.
