**HIGHWAYS ACT 1980, SECTION 65 and 66**

**A429 COVENTRY ROAD, WARWICK – PROPOSED COVERSION OF FOOTWAY TO  
SHARED USE FOOTWAY / CYCLE TRACK**

Warwickshire County Council propose under Section 65 and 66 of the Highways Act 1980 to convert the existing footways as described in Schedule 1 below into a shared use footway / cycle track and to convert the footways as described in Schedule 2 below into a segregated footway / cycle track.

**SCHEDULE 1**

**Conversion of Footway to Shared Use Footway / Cycle Track**

A429 Coventry Road, Warwick

1. West side, from the junction with The Paddocks to the junction with Station Road
2. West side, from the junction with Station Road to the junction with Lakin Road
3. West side, from the junction with Lakin Road northwards for approximately 15 metres
4. West side, from a point 235 metres north of Lakin Road, norward to the southern junction with Guys Cross Park Road
5. West side, between the two junctions with Guys Cross Park Road
6. West side, from the northern junction with Guys Cross Park Road to the junction with Rowan Drive
7. West side, from the junction with Rowan Drive, northwards for approximately 115 metres
8. East side, from the existing cycle link at Guy Street southwards for approximately 45 metres

9. East side, from the existing cycle link at Guy Street northwards to the junction with Station Avenue
10. East side, from the junction with Station Avenue northwards for approximately 25 metres

### **Conversion of Footway to Segregated Footway / Cycle Track**

A429 Coventry Road, Warwick

West side, from a point 15 metres north of Lakin Road, northwards for approximately 220 metres
