A429 COVENTRY ROAD, WARWICK-PROPOSED CONVERSION OF FOOTWAY

TO SHARED USE AND SEGREGATED FOOTWAY/CYCLE TRACK

1. Background

Modifications to the junction of Guys Cross Park Road with Coventry Road are proposed as part of a cycling infrastructure scheme to accommodate cyclists on a shared footway / cycleway, which will be segregated in some sections, along the west side of Coventry Road.

This will include the introduction of a prohibition of right turns from Guys Cross Park Road onto Coventry Road as part of the delivery of cycling infrastructure on the A429 Coventry Road.

2. Statement of Reasons

Warwickshire County Council is proposing, pursuant to sections 65 and 66 of the Highways Act 1980, to convert parts of existing footways on A429 Coventry Road (as described in the schedules below) into a shared & segregated use footway/cycle track for use by pedestrians and cyclists.

The shared & segregated use footway/cycle track is being introduced on sections of the A429 Coventry Road to provide a new cycle route between Spinney Hill roundabout and St John's in Warwick.

The scheme will involve widening of existing footways on the western and eastern sides of Coventry Road (as described in the Schedules below) to a minimum width of 3 metres to allow conversion to shared use footways / cycle tracks.

3. Schedule

SCHEDULE 1

Conversion of Footway to Shared Use Footway / Cycle Track

A429 Coventry Road, Warwick

1. West side, from the junction with The Paddocks to the junction with Station Road

2. West side, from the junction with Station Road to the junction with Lakin Road
3. West side, from the junction with Lakin Road northwards for approximately 15 metres
4. West side, from a point 235 metres north of Lakin Road, northwards to the southern junction with Guys Cross Park Road
5. West side, between the two junctions with Guys Cross Park Road
6. West side, from the northern junction with Guys Cross Park Road to the junction with Rowan Drive
7. West side, from the junction with Rowan Drive, northwards for approximately 115 metres
8. East side, from the existing cycle link at Guy Street southwards for approximately 45 metres
9. East side, from the existing cycle link at Guy Street northwards to the junction with Station Avenue
10. East side, from the junction with Station Avenue northwards for approximately 25 metres

SCHEDULE 2

Conversion of Footway to Segregated Footway / Cycle Track

A429 Coventry Road, Warwick

1. West side, from a point 15 metres north of Lakin Road, northwards for approximately 220 metres
