1. Background

1.1 Warwickshire County Council is proposing to introduce a 20mph speed limit throughout Henley in Arden, and a 140metre extension to the existing 30mph speed limit (by order) shown on the attached plans. (Drawing No PTRO22-031 & PTRO22-031-01)

2. Statement of Reasons

High Street (A3400), Henley-in-Arden – 20mph Speed Limit

In Henley town centre, an area of heavy pedestrian usage, a 20mph speed limit is proposed to avoid danger to persons or other traffic using the road and for preventing the likelihood of any such danger arising.

High Street(A3400),Henley-in-Arden – 30mph Speed Limit

North of Henley town centre, the existing 30 mph limit is proposed to be extended to act as a buffer zone between the highspeed rural road and the proposed 20mph urban environment, avoiding danger to persons or other traffic using the road and for preventing the likelihood of any such danger arising.

3. Schedule

Schedule 1 – 20mph Limit

1. A3400 Birmingham Road and High Street(A3400), Henley in Arden

From its junction with A4189 Warwick Road to a point 16.5metres north of its junction with Johnson Place on the A3400 Birmingham Road.

Schedule 2 – 30mph Speed Limit Extension (replacing 140 metres of existing 40mph speed limit)

1. High Street(A3400), Henley in Arden

From a point 16.5metres north of its junction with Johnson Place in a northerly direction for 340 metres
