ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (HENLEY-IN-ARDEN TO HOCKLEY HEATH ROAD A3400) (30 M.P.H., 40 M.P.H. AND 50 M.P.H. SPEED LIMITS) ORDER, 2000

The Warwickshire County Council, in exercise of its powers under Sections 82(2), 83(2) and 84(1)(a) and (2) of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of the Schedule 9 to the Act hereby makes the following Order:-

1. The 70 miles per hour, 60 miles per hour and 50 miles per hour (Temporary Speed Limit) Order 1977 as having effect by virtue of Section 265(9) of, and paragraph 9 of Schedule 21 to, the Highways Act 1980, insofar as it relates to the length of road specified in Schedule 1 to this Order, as if it were an Order made by the Warwickshire County Council is hereby revoked to the extent that its provisions shall no longer apply to that length of road.
2. The length of road specified in Schedule 2 to this Order shall be a restricted road for the purposes of Section 81 of the Act.
3. No person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the length of road specified in Schedule 3 to this Order.
4. No person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in Schedule 4 to this Order.
5. This Order may be cited as "The Warwickshire County Council (Henley-in-Arden to Hockley Heath Road A3400) (30 m.p.h., 40 m.p.h. and 50 m.p.h. Speed Limits) Order 2000" and shall come into operation on the 4<sup>th</sup> September 2000.

SCHEDULE 1

(Revocation of 50 m.p.h. Speed Limit)

That length of the Henley-in-Arden to Hockley Heath road A3400 (formerly part of A34 Trunk Road) which extends from a point 16.5 metres north of its junction with Johnson Place, Henley-in-Arden northwards to the Warwickshire/Solihull Borough Boundary.

SCHEDULE 2

(30 m.p.h. Speed Limit)

That length of the Henley-in-Arden to Hockley Heath road A3400 which extends from a point 16.5 metres north of its junction with Johnson Place, Henley-in-Arden northwards for 200 metres.

SCHEDULE 3

(40 m.p.h. Speed Limit)

That length of Henley-in-Arden to Hockley Heath road A3400 in the Parish of Beaudesert which extends from a point 216.5 metres north of its junction with Johnson Place, Henley-in-Arden to a point 44 metres south of its junction with Nuthurst Road, a distance of approximately 1,920 metres.

SCHEDULE 4

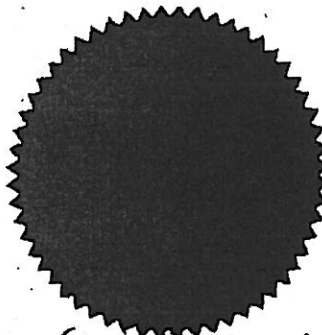
(50 m.p.h. Speed Limit)

That length of the Henley-in-Arden to Hockley Heath road A3400 which extends from a point in the Parish of Beaudesert 44 metres south of its junction with Nuthurst Road to the Warwickshire/Solihull Borough boundary, distance of approximately 3,370 metres.

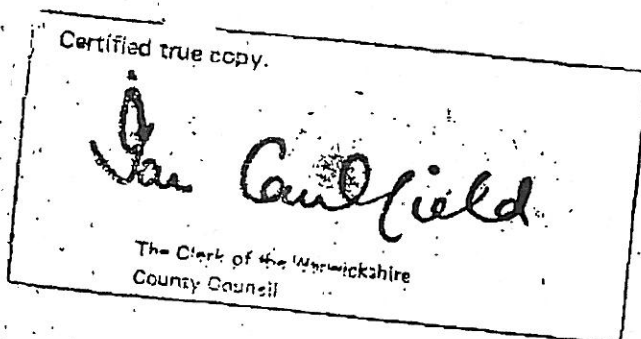
