ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL
(DISTRICT OF STRATFORD ON AVON) (CIVIL ENFORCEMENT AREA)
(WAITING RESTRICTIONS, ON STREET PARKING PLACES AND
RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION M) ORDER 2023

1. BACKGROUND

- 1.1 Request to apply No Waiting at any Time parking restrictions to the above named crossroads as part of a traffic signal installation to that junction has resulted in the following proposal.

2. STATEMENT OF REASONS

2.1 B4455, Fosse Way.

Fosse Way is the old historic north-south Roman Road which remains as a fairly straight line road through to today.

The approach to the Harbury Lane crossroads along the Fosse Way is uphill from both the north and south. From the north, there is a system of Double White centre lines to deter overtaking and from the south there is a Speed Camera site on this 50mph road.

However, over the last five years the Accident Statistics show that there was a total of ten incidents split as two Serious and eight Slight injury accidents.

As traffic is allowed to effectively 'free-flow' across the crossroads – when the way ahead is clear – the number of incidents is quite high. Therefore, to reduce the conflict manoeuvres a system of new traffic signals has been proposed to bring down the collision rate.

As part of any traffic signal proposal, a scheme of Double Yellow Lines is also proposed to protect the Vehicle Detection system to the traffic signals. This will prevent vehicles parking/waiting in certain areas defined by the Traffic Signals Team and will allow smooth and efficient operation of the junction as a whole.

This should have the effect of slowing motorists down on approach to the crossroads, assist turning traffic, preserve visibility and aid road safety.

3. SCHEDULE 1 - (No Waiting at any Time)

- 3.1 Plan Ref. PTRO22 026 01 to be included in Schedule 1 and attached to the Order.

3.2 B4455 Fosse Way

- (i) From an approximate centre line drawn from the centre of Harbury Ln carriageway centre, across to the Fosse Way to the carriageway centre of Chesterton Rd
- (ii) Fosse Way, northern side, northbound side for a distance of 21m.
- (iii) Fosse Way, northern side, southbound side for a distance of 24m.
- (iv) Fosse Way, southern side, northbound side for a distance of 23m.
- (v) Fosse Way, southern side, southbound side for a distance of 22m.

3.3 Harbury Lane.

- (i) From an approximate centre line drawn from the centre of Fosse Way carriageway, north and south sides of the Harbury Ln junction, in a north westerly direction for a distance of 128m.

3.4 Chesterton Road.

- (i) From an approximate centre line drawn from the centre of Fosse Way carriageway, north and south sides of the Chesterton Rd junction, in a south easterly direction for a distance of 127m.

- 4.1 The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017
