#### PROPOSED CONVERSION OF FOOTWAYS TO SHARED USE FOOTWAYS / CYCLE TRACKS AT KENILWORTH ROAD, NORTHUMBERLAND ROAD, CLOISTER CROFTS & WOODCOTE ROAD, LEAMINGTON SPA

### EXTENSION OF MANDATORY ON CARRIAGEWAY CYCLE LANE, CLARENDON AVENUE, LEAMINGTON SPA

#### 1. STATEMENT OF REASONS

- 1.1 Warwickshire County Council is proposing, pursuant to sections 65 and 66 of the Highways Act 1980, to convert parts of existing footways on Kenilworth Road, Northumberland Road, Cloister Crofts and Woodcote Road, Learnington Spa (as described with approximate measurements in the Schedule 1 below) into shared use footways/cycle tracks for use by pedestrians and cyclists in accordance with the proposed signage and markings, and extend the mandatory on carriageway cycle lane on Clarendon Avenue (as described with approximate measurements in the Schedule 2 below).
- 1.2 The shared use footway/cycle track is being introduced on sections of the A452 Kenilworth Road to support access onto a new cycle route between Learnington town centre and north Learnington, which is the first phase of a longer route between Learnington and Kenilworth (K2L).
- 1.3 These sections are in addition to those sections advertised in Autumn 2022 as part of the original proposals for the cycle route along the eastern side of the A452 Kenilworth Road in Learnington Spa. During local engagement, there were a number of requests for greater priority for pedestrians and cyclists at side roads and better access to the cycle route from the western side of Kenilworth Road.
- 1.4 This has led to modifications of the design of the original scheme in order to:
  - Provide a priority crossing for pedestrians and cyclists on Cloister Crofts. As this
    is set back from the junction with the A452 Kenilworth Road, it involves
    conversion to shared use footways / cycle tracks of existing footways on both
    sides of Cloisters Croft between Kenilworth Road and the crossing point, as
    described in the Schedule below.
  - Provide a better connection for cyclists to Woodcote Road. This involves conversion to shared use footways / cycle tracks of existing footways on the western side of Kenilworth Road between the signal-controlled crossing north of Woodcote Road and the junction of Woodcote Road and Kenilworth Road, as described in the Schedule below.
  - Provide a better connection for cyclists to Northumberland Road. The scheme will involve conversion to shared use footways / cycle tracks of existing footways on the western side of Kenilworth Road between a new crossing refuge south of Northumberland Road and the junction of Northumberland Road and Kenilworth Road, as described in the Schedule below.
- 1.5 The extension of the mandatory cycle lane will provide a continuous link along Clarendon Avenue between the Parade and Tavistock Street, enabling a safer connection between Learnington Town Centre and a new crossing refuge on Clarendon Avenue.

1.6 These modifications are detailed on drawing 9.2/A452/069/009E Scheme Overview Plan, A452 - Kenilworth Road.

A452 Kenilworth Road (western side)

- (i) At Northumberland Road junction, 30 metres extending south
- (ii) At Woodcote Road junction, 60 metres extending north

#### Northumberland Road (southern side)

(i) At Kenilworth Road junction, 15 metres extending west

#### Northumberland Road (northern side)

(i) At Kenilworth Road junction, 15 metres extending west

#### Cloister Crofts (northern side)

(i) At Kenilworth Road junction, 10 metres extending east

Cloister Crofts (southern side)

(i) At Kenilworth Road junction, 10 metres extending east

#### Woodcote Road (northern side)

(i) At Kenilworth Road junction, 20 metres extending west

## SCHEDULE 2

## (extension of mandatory on carriageway cycle lane)

Drawing 9.2/A452/069/009E to be included in Schedule

#### Clarendon Avenue, Learnington Spa

The length of carriageway on the South side of Clarendon Avenue, commencing approximately 36 metres west of its junction with the Parade for a distance of approximately 28 metres with a width of 2.0 metres in a westerly direction towards the junction with Tavistock Street.
