ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL
(BOROUGH OF NORTH WARWICKSHIRE) (WAITING RESTRICTIONS AND ON-STREET
PARKING PLACES) (CONSOLIDATION) (VARIATION NO. 8) ORDER 2023

Warwickshire County Council propose to make the above named Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing Warwickshire County Council (Borough of North Warwickshire) (Waiting Restrictions and On-Street Parking Places) (Consolidation) Order 2017, as described (by approximate measurements) in the Schedule below.

Exceptions to any waiting restrictions described in the Schedule below will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

SCHEDULE

Coventry Road, Coleshill – No Waiting at any Time

East side, from a point 13 metres north of its junction with Packington Lane, southwards for 75 metres

Packington Lane, Coleshill – No Waiting at any Time

- (i) North Side, from its junction with Coventry Road south-eastwards for 205 metres
- (ii) South side, from its junction with Coventry Road south-eastwards for 80 metres

Packington Lane, Coleshill – No Waiting Mon-Fri 8.30am-9.30am and 2.30pm-3.30pm

West side, from a point 80 metres southwest of its junction with Coventry Road, southwards for 119 metres
