ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL
(GLASSHOUSE LANE, EDWARDS GROVE AND DENEWOOD WAY, KENILWORTH)
(30 & 50 MPH SPEED LIMITS) ORDER 2012

The Warwickshire County Council, in exercise of its powers under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. Save as provided in Article 3 below, no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 1 to this Order.
2. Save as provided in Article 3 below, no person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road specified in Schedule 2 to this Order.
3. The provisions of Articles 1 and 2 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
4. This Order may be cited as "The Warwickshire County Council (Glasshouse Lane, Edwards Grove and Denewood Way, Kenilworth) (30 & 50 mph Speed Limits) Order 2012" and shall come into operation on the 26th day of March Two thousand and twelve.

SCHEDULE 1
(30 mph speed limit)

(i) **Denewood Way, Kenilworth**

The entire length from its junction with Glasshouse Lane.

(ii) **Edwards Grove, Kenilworth**

The entire length from its junction with Glasshouse Lane.

(iii) **Glasshouse Lane, Kenilworth**

From a point 272 metres north-east of the access leading to property numbers 91 to 111 Glasshouse Lane, south-eastwards then south-westwards to a point 25 metres south-west of that same junction.

SCHEDULE 2
(50 mph speed limit)

Glasshouse Lane, Kenilworth

From a point 82 metres north-west from its junction with Denewood Way, south-eastwards to a point 272 metres north-east of the access leading to property numbers 91 to 111 Glasshouse Lane.
