SECTION 90A HIGHWAYS ACT 1980

GLASSHOUSE LANE, KENILWORTH - PROPOSED ROAD HUMPS

Warwickshire County Council proposes to:

- Install a series of Road Humps (Speed Cushions and Raised Tables) under section 90A of the Highways Act 1980, on Glasshouse Lane, Kenilworth, at the locations described in Schedule 1 and 2 below.

SCHEDULE 1

(Proposed Speed Cushions - Road Humps)

Glasshouse Lane, Kenilworth

- (i) Set of 2No cushions located 108 metres south-east of its junction with Crewe Lane (opposite 4 Denewood Way)
- (ii) Set of 3No cushions located 178 metres south-east of its junction with Crewe Lane (opposite 1 Denewood Way, and 6 Chatsworth Grove)
- (iii) Set of 3No cushions located 248 metres south-east of its junction with Crewe Lane (opposite 9 Chatsworth Grove)
- (iv) Set of 2No cushions located 353 metres south-east of its junction with Crewe Lane (opposite 70 Leyes Lane)
- (v) Set of 2No cushions located 383 metres south-east of its junction with Crewe Lane (opposite 12-16 Cornhill Grove)

Dimension of each speed cushion: 1.6m (width) x 3.5m (length) x 0.075m (height)

SCHEDULE 2

(Proposed Raised Tables - Road Humps)

Glasshouse Lane, Kenilworth

- (i) located 172 metres south-east of its junction with Denewood Way (opposite 7 Wisley Grove)
- (ii) located 308 metres south-east of its junction with Denewood Way (opposite 1 Edwards Grove)

Dimensions of each Raised Table : 6.1m (width) x 12m (length) x 0.075m (height)
