(WAITING RESTRICTIONS, ON STREET PARKING PLACES AND  
RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION D) ORDER 2023**

The Warwickshire County Council in exercise of its powers under section 1(1) and (2), 2(1) to (3) 4(2) and 122A of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, (hereinafter referred to as "the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

1. The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area)(Waiting Restrictions, On Street Parking Places and Residents' Parking)(Consolidation) Order 2017 (which said Order of 2017 is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
2. In this Order 'Road' shall mean those roads cross hatched black and solid black and identified on the Plan TR11353/01 Revision C attached to this Order
3. In Schedule 2 "Plans attached to this Order" insert Plan JV46 Revision 1.
4. In Schedule 2 "Plans attached to this Order" insert Plan JV47 Revision 1.
5. In Schedule 2 "Plans attached to this Order" insert Plan TR11353/01 Revision C.
6. In Schedule 2 to the Principal Order insert those plans listed in Schedule 1 below and attached to this Order.
7. In the Principal Order insert the following wording as Article 8A :

"8A. Save as provided within Articles 11(1) (c)(ii), (d) and (h) no person shall, except in the case of emergency upon the direction or with the permission of a police constable in uniform or a civil enforcement officer, or when the person in control of the vehicle is required by law to stop or is obliged to stop to avoid an accident or is prevented from proceeding by circumstances outside his control, cause or permit a vehicle to stop in the lengths of road identified on the plans as "no stopping except in emergency" or "no stopping".
8. The provisions of this order shall come into operation and take effect immediately as and when each Road is opened for public use and may be cited as "The Warwickshire County Council (District of Stratford on Avon)(Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) (Variation D) Order 2023".
