**THE WARWICKSHIRE COUNTY COUNCIL (GLASSHOUSE LANE AND DENEWOOD WAY, KENILWORTH) (30 MPH SPEED LIMIT) ORDER 2023**

**1. BACKGROUND**

- 1.1 As part of the approved plans to relocate Kenilworth School and Sixth Form, a request has been received by Warwickshire County Council's Design Services team to implement a 20mph zone on part of Glasshouse Lane and part of Denewood Way, and the entirety of Edwards Grove, Kenilworth, adjacent to the Kenilworth School site. The 20mph zone includes proposed Road Humps (Speed Cushions and Raised Tables) to help slow traffic in-line with the reduced speed limit.
- 1.2 There is a further request to extend the current 30mph speed limit south of the Kenilworth School site, reducing the current limit of 50mph.

**2. STATEMENT OF REASONS**

- 2.1 A 20mph zone is proposed for part of Glasshouse Lane and the part of Denewood Way accessed from Glasshouse Lane, and the entirety of Edwards Grove, Kenilworth, adjacent to the new school site to improve safety and accessibility for pedestrians and cyclists, in line with the construction of the new school and to facilitate the installation of the proposed road humps (Speed Cushions and Raised Tables). Please refer to Schedule 1.
- 2.2 An extension of the current 30mph speed limit is proposed for Glasshouse Lane, Kenilworth, replacing the current 50mph limit, to improve safety and accessibility for pedestrians and cyclists in line with the construction of the new school. Please refer to Schedule 2. The part of Denewood Way accessed from Hidcote Road will remain a 30mph speed limit. Please refer to Schedule 2.

**3.1 SCHEDULES**

**SCHEDULE 1**  
**(20mph zone)**

- (i) Glasshouse Lane, Kenilworth

From a point 55 metres south-east of Crewe Lane, south-eastwards for a distance of 490 metres.

(ii) Edwards Grove, Kenilworth

The entire length from its junction with Glasshouse Lane.

(iii) Denewood Way, Kenilworth

From its junction with Glasshouse Lane (the section leading to property numbers 1 to 6) in a south westerly direction for a distance of 17 metres and then from this point in a north westerly direction for a distance of 28 metres and in a south easterly direction for 10 metres.

**SCHEDULE 2**  
**(30mph speed limit)**

(i) Glasshouse Lane, Kenilworth

From a point 25 metres south-west of the access leading to property numbers 91 to 111 Glasshouse Lane, north-eastwards then north-westwards for a distance of 420 metres.

(ii) Denewood Way, Kenilworth

From its junction with Hidcote Road (the section leading to property numbers 7 to 15) in a south easterly direction for a distance of 71 metres.
