ROAD TRAFFIC REGULATION ACT 1984, SECTION 14

THE WARWICKSHIRE COUNTY COUNCIL (LEAM TERRACE AND VARIOUS ROADS, LEAMINGTON SPA) (20 MPH SPEED LIMIT) ORDER 2023

The Warwickshire County Council in exercise of its powers under section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, hereby make the following Order: -

- 1. Save as provided in Article 2 below, no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road described in the Schedule to this Order.
- 2. The provisions of Article 1 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
- 3. This Order may be cited as "The Warwickshire County Council (Leam Terrace and Various Roads, Leamington Spa) (20mph Speed Limit) Order 2023" and shall come into operation on the 3rd day of July Two Thousand and Twenty-Three

SCHEDULE

1. Leam Terrace, Leamington Spa

From its junction with Willes Road in an eastern direction to its junction with Radford Road.

2. St Mary's Road, Leamington Spa

From its junction with Leam Terrace to its junction with Willes Road.

3. Willes Terrace, Leamington Spa

From its junction with St Mary's Road to its junction with Leam Terrace.

4. Beaconsfield Street West, Learnington Spa

From its junction with Lower Leam Street to its junction with St Mary's Road.

From its junction with St Mary's Road to its junction with Leam Terrace.

8. Northcote Street, Leamington Spa

From its junction with Willes Road for its entirety.
