ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL
(DISTRICT OF STRATFORD ON AVON) (CIVIL ENFORCEMENT AREA)
(WAITING RESTRICTIONS, ON STREET PARKING PLACES AND
RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. O) ORDER 2024

Warwickshire County Council proposes to make the above-named Variation Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing District of Stratford on Avon (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017, as briefly described (by approximate measurements) in the Schedule below.

Exceptions will permit waiting for the purposes of picking up and setting down passengers, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

(No Waiting At Any Time)

Chestnut Way, Bidford on Avon

Both sides, from its junction with Wellington Road, westwards for 13.5 meters.

Waterloo Road, Bidford on Avon

- (i) Both sides, from its junction with Wellington Road, northwards for 11 meters.
- (ii) Both sides, from its junction with Wellington Road, southwards for 26 meters.

Wellington Road, Bidford on Avon

Both sides, from its junction with Waterloo Road, eastwards for 140 meters.
