**HIGHWAYS ACT 1980, SECTION 90A**

**PROPOSED ROAD HUMPS (SPEED CUSHIONS)**

Warwickshire County Council proposes to install 8 sets of road humps (speed cushions), varying between 2 to 3 no. cushions per set, pursuant to Section 90A of the Highways Act 1980, upon those lengths of road as described in the schedule below.
