ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (LOXLEY ROAD/STRATFORD ROAD,  
LOXLEY LANE, KNIGHTS LANE, PIMLICO LANE, CHURCH LANE ALVESTON,  
KISSING TREE LANE ALVESTON, ALVESTON HILL, HUNSCOTE LANE AND  
CHARLECOTE ROAD) (50 MPH SPEED LIMIT) ORDER 2012

The Warwickshire County Council, in exercise of its powers under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

1. Save as provided in Article 2, no person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in the Schedule to this Order.
2. The provisions of Article 1 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
3. This Order may be cited as "The Warwickshire County Council (Loxley Road/Stratford Road, Loxley Lane, Knights Lane, Pimlico Lane, Church Lane Alveston, Kissing Tree Lane Alveston, Alveston Hill, Hunscombe Lane and Charlecote Road) (50 mph Speed Limit) Order 2012" and shall come into operation on the Nineteenth day of November Two thousand and twelve.

SCHEDULE

1. Alveston Hill

From its junction with Loxley Road, in a southerly direction to its junction with the A422 Banbury Road, a distance of 1.8 kilometres.

2. Charlecote Road

From its junction with the B4086 Stratford Road, in a northerly direction to a point 385 metres south of its junction with Wellesbourne Road, a distance of 430 metres.

3. Church Lane, Alveston

From its junction with Wellesbourne Road, in a northerly direction to a point 127 metres south of its junction with Kissing Tree Way, a distance of 120 metres.

4. Hunscombe Lane

From its junction with Loxley Lane, in a westerly direction for the whole length, a distance of 1.75 kilometres.

5. Kissing Tree Lane, Alveston

From its junction with Wellesbourne Road, in a northerly direction to a point 118 metres south of its junction with Avonfields Close, a distance of 252 metres.

6. Knights Lane, Tiddington

From its junction with Loxley Road, in a northerly direction to its junction with Townsend Road, a distance of 453 metres.

7. Loxley Lane

From its junction with the B4086 Stratford Road, in a southerly direction to its junction with Loxley Road, a distance of 2.05 kilometres.

8. Loxley Road/Stratford Road

(i) From its junction with the A429 Ettington Road, in a south/westerly direction to a point 40 metres north of its junction with Redhill Road, a distance of 2.28 kilometres; and

(ii) From a point 275 metres west of its junction with Goldicote Road, in a westerly direction to a point 195 metres west of its junction with Knights Lane, a distance of 3.85 kilometres.

9. Pimlico Lane

(i) From its junction with Loxley Road, in a northerly direction to its junction with the B4086 Wellesbourne Road, a distance of 1.53 metres; and

(ii) From its junction with Loxley Road, in a south westerly direction to its junction with Alveston Hill, a distance of 353 metres.
