**ROAD TRAFFIC REGULATION ACT 1984**

**THE WARWICKSHIRE COUNTY COUNCIL (BOROUGH OF NORTH WARWICKSHIRE)  
(WAITING RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION)  
(VARIATION D) ORDER 2024**

Warwickshire County Council propose to make the above-named Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing Warwickshire County Council (Borough of North Warwickshire) (Waiting Restrictions and On-Street Parking Places) (Consolidation) Order 2017, as described (by approximate measurements) in the Schedule below.

Exceptions to any waiting restrictions described in the Schedule below will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

**SCHEDULE**  
**(Proposed No Waiting At Any Time)**

**Church Road, Hartshill**

- (i) North-west side, from a point 50 metres north-east of its junction with Hayes Road, north-eastwards for 64 metres.
- (ii) South-east side, from a point 43 metres north-east of its junction with Victoria Road north-eastwards to the entrance to Hartshill School.
- (iii) South-east side, from the centreline of the entrance to Hartshill School north-eastwards for 13 metres.

**Church Road, Hartshill - entrance to Hartshill Medical Practice**

Both sides, from its junction with Church Road, north-westwards for 3 metres.

**Church Road, Hartshill - entrance to Hartshill School**

Both sides, from its junction with Church Road, south-eastwards for 8 metres.
