# THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF WARWICK) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON-STREET PARKING PLACES AND RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION Q) ORDER 2024

### 1. BACKGROUND

1.1 As part of the wider Warwick Town Centre proposals, Warwickshire County Council's Transport Planning team have developed a scheme to improve St Johns junction to ease vehicle flows and improve facilities for pedestrians and cyclists.

# 2. STATEMENT OF REASONS

The proposed variation order seeks implement waiting restrictions and provide parking bays for Blue Badge Holders, for Loading and for Limited Waiting as described in Schedule 1 below. Appropriate signage and road markings would be installed to advise highway users of the prohibitions and enable civil enforcement of the restrictions.

Introduction of waiting restrictions and parking bays will have the effect of facilitating the passage on the road of all traffic and avoiding danger to persons or other traffic using the road and prevent the likelihood of any such danger arising.

### No Waiting At Any Time

- (i) D4129 St Johns (service road) from a point 63 metres south of its junction with The Paddocks, south eastward for 8 metres
- (ii) A429 St Johns from its junction with Priory Road, north eastwards for 30.9 metres
- (iii) Priory Road (northern side) from its junction with A429 St Johns westward for 24.8 metres
- (iv) Priory Road (southern side) from its junction with Smith Street westward for 21.9 metres
- (v) Smith Street (northern side) from its junction with Priory Road south westward for 25.2 metres
- (vi) Smith Street (southern side) from its junction with A429 St Johns south westward for 22.9 metres

- (vii) St Nicholas Church Street (eastern side) from its junction with A429 St Johns southward for 27.5 metres
- (viii) St Nicholas Church Street (western side) from its junction with A429 St Johns southward for 22.8 metres
- (ix) A429 St Johns from its junction with St Nicholas Church Street eastward for 10.3 metres

## Revocation of No Waiting at any Time

(i) D4129 St Johns (service road) from a point 7 metres north of its junction with The Paddocks, northward for 5 metres

## Limited Waiting - Mon-Sat 9am-5pm 1 Hour No Return 2 hours

- (i) D4129 St Johns (service road) from a point 7 metres north of its junction with The Paddocks, northward for 5 metres
- (ii) D4129 St Johns (service road) from a point 10 metres south of its junction with The Paddocks, southward for 53 metres

## Revocation of Limited Waiting - Mon-Sat 9am-5pm 2 Hours No Return 4 Hours

- (i) D4129 St Johns (service road) from a point 63 metres south of its junction with The Paddocks, south westward for 22 metres
- (ii) A429 St Johns from a point 4 metres east of its junction with Priory Road, eastwards for 23 metres.

### Disabled Badge Holders Only

(i) D4129 St Johns (service road) from a point 71 metres south of its junction with The Paddocks, south westward for 6.6 metres

### Loading Only

(i) D4129 St Johns (service road) from a point 77.6 metres south of its junction with The Paddocks, south westward for 8.6 metres
