**ROAD TRAFFIC REGULATION ACT 1984**

**THE WARWICKSHIRE COUNTY COUNCIL B4452 UFTON ROAD AND DEEPERS  
BRIDGE ROAD, BUSH HEATH ROAD AND BUTT LANE, HARBURY (40MPH  
SPEED LIMIT) ORDER 2024**

Warwickshire County Council proposes to make the above-named Order under the Road Traffic Regulation Act 1984, the effect of which would be:

- to impose a 40-mph speed limit on the lengths of road mentioned in Schedule 1 below;
- to revoke the (Various Roads, Harbury) (40 M.P.H. Speed Limit) 1995 Order

The provisions of any other Order made pursuant to the Road Traffic Regulation Act 1984 (or pursuant to any legislation in force prior thereto) which imposes a speed limit on the length of road referred to in Schedule 1 below are proposed to be revoked in respect of that said length of road.

**SCHEDULE 1**

**(40 mph Speed Limit)**

**B4452 Deepers Bridge Road**

From its junction with B4452 Ufton Road for a total distance of 630 metres in an easterly direction.

**B4452 Ufton Road**

From its junction with B4452 Deepers Bridge Road in a northerly direction to a point 240 metres north of its junction with Hall Lane.

**Bush Heath Road**

In its entirety from its junction with Plough Lane in a north easterly direction to its junction with Vicarage Lane and Butt Lane.

**Butt Lane**

In its entirety from its junction with Vicarage Lane and Bush Heath Road in a northerly direction to its junction with B4452 Ufton Road and B4452 Deepers Bridge Road.
