MODIFICTATION TO ADVERTISED PROPOSALS

Warwickshire County Council has modified the proposals advertised in its Public Notice dated 09 February 2024, relating to the above-named Variation Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing District of Stratford on Avon (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017.

The modifications to the proposals are as described in Schedule 1 below. All other proposals remain as per the 09 February 2024 Public Notice.

Exceptions will permit waiting for the purposes of picking up and setting down passengers, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.
