# THE WARWICKSHIRE COUNTY COUNCIL (LINK ROAD NORTH, RUGBY) (PROHIBITION OF RIGHT AND LEFT TURNS) (VARIATION NO.2) ORDER 2024

Warwickshire County Council propose to make the above Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing Warwickshire County Council (Link Road North) (Prohibition of right and left turns) (Variation No. 1) Order 2020, as briefly described in the Schedule below.

#### **SCHEDULE**

## 1. Houlton Way

Item (ii) of the existing Order is to be deleted in its entirety and replaced with the following wording to now allow for right turns to made into Hillmorton Lane when travelling in a south easterly direction. The no left turn into Hillmorton Lane at the junction with Houlton Way will remain in place.

"From Houlton Way travelling in a south easterly direction, no left turn at the Hillmorton Lane junction into Hillmorton Lane".

## 2. Hillmorton Lane

Item (i) and (ii) of the existing Order are to be deleted in their entirety.

When travelling in a northerly direction left hand turns from Hillmorton Lane onto Houlton Way will now be permitted at the junction of Hillmorton Lane and Houlton Way.

A new item (i) will be inserted with the following wording to allow for right turns to made onto Houlton way at the junction with Hillmorton Lane, when travelling in a southerly direction. The no left turn into Houlton Way will remain in place.

"From Hillmorton Lane, travelling in a southerly direction, no left turn at its junction with Houlton Way, into Houlton Way.
