The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), the Traffic Management Act 2004, and of all other enabling powers, hereby make the following Order:-

## PART I CITATION AND INTERPRETATION

- The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
- 2. In Schedule 1 to the Principal Order, under the heading of Zone L6, insert:-
  - "Farley Street"
  - "Gordon Street"
  - "New Street"; and
  - "Plymouth Place"
- 3. In Schedule 2 to the Principal Order, after Plan Title "FY61", replace the revision number "2" with the revision number "3".
- 4. In Schedule 2 to the Principal Order, after Plan Title "FY62", replace the revision number "0" with the revision number "1".
- 5. In Schedule 2 to the Principal Order, after Plan Title "FZ61", replace the revision number "2" with the revision number "3".
- 6. In Schedule 2 to the Principal Order, after Plan Title "FZ62", replace the revision number "1" with the revision number "2".
- 7. In the Principal Order, replace the plans attached thereto which are listed in column 1 of the Schedule below, with the plans attached to this Order and listed in column 2 of the Schedule below.
- 8. This Order shall come into operation on the day of Two thousand and twenty-four and may be cited as "The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) (Variation No. 13) Order 2024".
