- 3. In Schedule 2 to the Principal Order add the plan attached hereto and listed in Schedule 1 below.
- 4. This Order shall come into operation on the 26th day of August Two thousand and twenty four and may be cited as "The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) (Variation No. O) Order 2024"


