ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS STREETS, STRATFORD UPON AVON) (20 MPH SPEED LIMIT) ORDER 2024

1. BACKGROUND

1.1 As part of Warwickshire County Council's response to the Covid-19 pandemic, a temporary 20 mph speed limit was introduced in parts of Stratford-upon-Avon Town Centre to aid social distancing measures. Following the expiry of the temporary speed limit order, requests have been received by Warwickshire County Council to introduce a permanent 20 mph speed limit. This has resulted in the proposals as detailed below.

2. STATEMENT OF REASONS

2.1 <u>Various Streets, Stratford</u>

Proposals are for the streets listed in the Schedule 1 below to be within a 20 mph speed limit for the following reasons:

- (i) To reduce the risk of conflict between vehicular traffic, pedestrians and other road users, avoiding danger to persons or other traffic using the road and for preventing the likelihood of any such danger arising.
- (ii) for preserving or improving the amenities of the area through which the road runs
