THE WARWICKSHIRE COUNTY COUNCIL (STATION ROAD & WHARF ROAD, FENNY COMPTON) (40 MPH SPEED LIMIT) ORDER 2024

THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, FENNY COMPTON) (20 M.P.H. AND 30 M.P.H SPEED LIMIT) (VARIATION NO.1) ORDER 2024

Warwickshire County Council proposes to make the above-named Orders, pursuant to the Road Traffic Regulation Act 1984, the effect of which will be to:

- Remove the current National Speed Limit (60mph) and replace it with a 40mph speed limit, on the lengths of road described in Schedule 1 below; and
- Vary the 30mph speed limit on the lengths of road described in Schedule 2 below.

SCHEDULE 1 (Proposed NSL 60mph to 40mph Speed Limit)

1. Station Road, Fenny Compton

From a point 400 metres north-eastwards of its junction with High Street, for its entire length, to its junction with Wharf Road.

2. Wharf Road, Fenny Compton

From its junction with Station Road, in a north easterly direction for its entire length, to its junction with the A423 and including the entire length of Wharf Road which terminates at the Oxford Canal Walk Bridge.

SCHEDULE 2
(Variation to 30mph Speed Limit)

1. High Street, Fenny Compton

From a point 50 metres north-east of its junction with Cotters Croft in a north-easterly direction to its junction with Station Road,

2. Station Road, Fenny Compton

From its junction with High Street in an easterly and north-easterly direction for 400 metres.
