ROAD TRAFFIC REGULATION ACT 1984

**THE WARWICKSHIRE COUNTY COUNCIL (B4452 UFTON ROAD
AND DEPPERS BRIDGE ROAD, BUSH HEATH ROAD AND BUTT
LANE, HARBURY) (40MPH SPEED LIMIT) ORDER 2024**

The Warwickshire County Council in exercise of its powers under Sections 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”), and of all other enabling powers, hereby make the following Order:


1. Save as provided in Article 2, no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road described in the Schedule to this Order.
2. The provisions of Article 1 of this Order shall not apply to vehicles falling within Regulation 3(4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when driven in accordance with Regulation 3(5) of
3. The provisions of any Order made pursuant to the Road Traffic Regulation Act 1984 (or pursuant to any legislation in force prior thereto) which imposes a speed limit on the length of roads referred to in Schedule 1 below are hereby revoked in respect of that said length of road. The Order dated 23rd October 1995 titled (Various Roads, Harbury) (40 M.P.H. Speed Limit) is hereby revoked in its entirety.
4. This Order may be cited as “The Warwickshire County Council (B4452 Ufton Road and Deppers Bridge Road, Bush Heath Road and Butt Lane, Harbury) (40 mph Speed Limit) Order 2024” and shall come into operation on 2nd September 2024.

SCHEDULE 1

(40mph)



1. B4452 Deppers Bridge Road
From its junction with B4452 Ufton Road for a total distance of 630 metres in an easterly direction.
2. B4452 Ufton Road
From its junction with B4452 Deppers Bridge Road in a northerly direction to a point 240 metres north of its junction with Hall Lane.
3. Bush Heath Road
In its entirety from its junction with Plough Lane in a north easterly direction to its junction with Vicarage Lane and Butt Lane.
4. Butt Lane
In its entirety from its junction with Vicarage Lane and Bush Heath Road in a northerly direction to its junction with B4452 Ufton Road and B4452 Deppers Bridge Road.
