ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (BOROUGH OF NORTH WARWICKSHIRE) (WAITING RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION) (VARIATION NO. 9) ORDER 2024

Warwickshire County Council propose to make the above-named Order under the Road Traffic Regulation Act 1984, the effect of which will be to vary the existing Warwickshire County Council (Borough of North Warwickshire) (Waiting Restrictions and On-Street Parking Places) (Consolidation) Order 2017, as described (by approximate measurements) in the Schedules below.

Exceptions to any waiting restrictions described in the Schedule below will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

SCHEDULE 1 **(Proposed No Waiting At Any Time)**

Barn Close, Dordon

Both sides, from its roundabout junction with Kitwood Avenue & Roman Way, westwards for 10 metres

South side, from a point 32 metres west of its roundabout junction with Kitwood Avenue & Roman Way, westwards for 18 metres

South side, from a point 115 metres west of its roundabout junction with Kitwood Avenue & Roman Way, south-westwards for 5 metres

North side, from a point 38 metres west of its roundabout junction with Kitwood Avenue & Roman Way, westwards for the remainder of its length (including the cul-de-sac section)

Barn Close (Service Road fronting even numbers 2-24), Dordon

South-east side, from its northern junction with Barn Close, southwards and westwards to its southern junction with Barn Close

North side, from its northern junction with Barn Close, westwards for 10 metres

West side, from its southern junction with Barn Close, northwards for 2 metres

Church Road, Hartshill

East side, from a point 13 metres south of its junction with Church Close, southwards for 12 metres

West side, from a point 25 metres south of its junction with Church Close, northwards for 30 metres

Coventry Road, Kingsbury

Both sides, from a point 31 metres south of its southern junction with Mill Crescent, northwards for 318 metres

Derek Avenue, Dordon

Both sides, from a point 20 metres east of its junction with Long Street, eastwards for 5 metres
North side, from a point 40 metres east of its junction with Long Street, eastwards for 49 metres
South side, from a point 45 metres east of its junction with Long Street, eastwards for 8 metres
South side, from a point 90 metres east of its junction with Long Street, eastwards for 5 metres

Lyon Court, Coleshill

North side, from its junction with Parkfield Road, eastwards for 15 metres
South side, from its junction with Parkfield Road, eastwards for 10 metres

High Street, Polesworth

Both sides, from a point 183 metres east of its junction with Bridge Street, eastwards for 7 metres

Hemlingford Road, Kingsbury

Both sides, from its junction with Mill Crescent, southwards for 10 metres

Kitwood Avenue, Dordon

Both sides, from a point 10 metres south of its roundabout junction with Barn Close and Roman Way, northwards for 56 metres

Maxstoke Lane, Coleshill

North side, from a point 125 metres east of its junction with High Street, eastwards for 147 metres
South side, from a point 135 metres east of its junction with Coventry Road, eastwards for 137 metres

Mill Crescent, Kingsbury

North side, from its southern junction with Coventry Road, eastwards for 20 metres
North side, from a point 40 metres east of its southern junction with Coventry Road, eastwards for 90 metres
South side, from its southern junction with Coventry Road, eastwards for 100 metres
Both sides, from its northern junction with Coventry Road, eastwards for 10 metres

Newlands Road, Baddesley Endors

Both sides, from its junction with New Street, eastwards for 27 metres

New Street, Baddesley Endors

East side, from its junction with Newlands Road, northwards for 15 metres
West side, from a point 10 metres north of its junction with Walnut Croft, southwards for 35 metres

Old Kingsbury Road, Kingsbury

Both sides, from its junction with Coventry Road, westwards for 57 metres

Parkfield Road, Coleshill

North-east side, from a point 10 metres south-east of its junction (centre-line) with Lyon Court, north-westwards for 20 metres

Roman Way, Dordon

Both sides, from its roundabout junction with Kitwood Avenue and Barn Close, eastwards for 10 metres

Sherwood Close, Wood End

Both sides, from its junction with Tamworth Road southwards for 12 metres

Smith Street, Wood End

Both sides, from its junction with Tamworth Road, southwards for 10 metres

South View, Kingsbury

Both sides, from its junction with Mill Crescent, northwards for 10 metres

Tamworth Road, Wood End

North side, from its junction with Sherwood Close, eastwards for 65 metres

South side, from a point 12 metres west of its junction with Sherwood Close, eastwards for 120 metres

Walnut Croft, Baddesley Endors

Both sides, from its junction with New Street, westwards for 13 metres

Woodlands Close, Dordon

South side, from a point 17 metres east of its junction with Long Street, eastwards for 48 metres

SCHEDULE 2

(Proposed Revocation of Existing No Waiting At Any Time)

Maxstoke Lane, Coleshill

South side, from a point 20 metres east of its junction with Coventry Road, eastwards for 49 metres

South side, from a point 84 metres east of its junction with Coventry Road, eastwards for 40 metres
