THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF STRATFORD ON AVON) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON STREET PARKING PLACES & RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 9) (PART 1) ORDER 2025

Warwickshire County Council has made the above-named Order, pursuant to the Road Traffic Regulation Act 1984, the effect of which is to vary the existing Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places & Residents' Parking) (Consolidation) Order 2017 (as varied) as described in Schedule 1 below. The above-named Order will commence on 10 February 2025.

A decision on the advertised proposals described in Schedule 2 below has been deferred.

Any person who desires to question the validity of the above-named Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order may within six weeks from the date of the making of the Order apply to the High Court for this purpose.
