(DISTRICT OF STRATFORD ON AVON) (CIVIL ENFORCEMENT AREA)
(WAITING RESTRICTIONS, ON STREET PARKING PLACES
AND RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 11) ORDER 2025

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), the Traffic Management Act 2004, and of all other enabling powers, hereby make the following Order:-

1. The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 is hereinafter referred to as 'the Principal Order') is hereby varied in the manner and to the extent hereinafter provided.
2. In the Principal Order, delete Articles 31(15) and 31(16) entirely and replace with:-
 - “(15) The Samaritans of Stratford on Avon may apply to the Council for the issue of a Zone S4 permit for the leaving of a motor car or motor cycle in a parking place in Zone S4 between the hours of 6.00pm and 8.00am.
 - (16) On receipt of an application made under the foregoing provisions of paragraph (15) of this Article, the Council may issue to The Samaritans of Stratford on Avon (either virtually or otherwise) up to four permits for the leaving of any motor car or motor cycle in a parking place in Zone S4 between the hours of 6.00pm and 8.00am. Provided that there shall not be in force at any time more than four permits issued under the provisions of this paragraph (16).”
3. In Schedule 1 to the Principal Order, delete the heading “ZONE S2 OR ZONE S3” and replace with the heading:-

“ZONE S2 OR ZONE S3 OR ZONE S4”
4. In Schedule 1 to the Principal Order, under the new heading “ZONE S2 OR ZONE S3 OR ZONE S4” delete the entire description of “Arden Street” and replace with:-

“Arden Street (excluding Maison 1 and property numbers 8, 9, 10, 11, 12, 13, 14, 15, 16 & 17)”
5. In Schedule 2 to the Principal Order, after Plan Title “HL37”, replace the revision number with the revision number “2”.
6. In Schedule 2 to the Principal Order, after Plan Title “HM37”, replace the revision number with the revision number “2”.
7. In Schedule 2 to the Principal Order, after Plan Title “HN37”, replace the revision number with the revision number “5”.

8. In the Principal Order, replace the plans attached thereto which are listed in column 1 of the Schedule below, with the plans attached to this Order and listed in column 2 of the Schedule below.
9. This Order shall come into operation on the _____ day of _____ Two thousand and twenty-five and may be cited as “The Warwickshire County Council (District of Stratford on Avon) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents Parking) (Consolidation) (Variation No. 11) Order 2025”.
