**ROAD TRAFFIC REGULATION ACT 1984**

**THE WARWICKSHIRE COUNTY COUNCIL (GLASSHOUSE LANE AND DENEWOOD WAY, KENILWORTH) (30 MPH SPEED LIMIT) (VARIATION NO. 1) ORDER 2025**

**SECTION 65 HIGHWAYS ACT 1980**

**SHARED USE FOOTWAY / CYCLE TRACK**  
**GLASSHOUSE LANE & STANSFIELD GROVE, KENILWORTH**

Warwickshire County Council proposes to:

- vary the existing 'The Warwickshire County Council (Glasshouse Lane and Denewood Way, Kenilworth) (30 mph Speed Limit) Order 2023', to remove the 30mph speed limit imposed on the length of road described in Schedule 1 below by virtue of the Order, due to that length of road becoming a restricted road, with a 30mph speed limit being imposed, by virtue of a new system of streetlighting; and
- construct a shared use footway/cycle track for use by pedestrians and cyclists, pursuant to Section 65 of the Highways Act 1980, on the lengths of road described in Schedule 2 below.

**SCHEDULE 1**

**(30 mph Speed Limit- revocation of 30mph by Order due to imposition of restricted road status by virtue of a system of streetlighting)**

**Glasshouse Lane, Kenilworth**

- (i) From a point 25 metres south-west of the access leading to property numbers 91 to 111 Glasshouse Lane, north-eastwards then north-westwards for a distance of 420 metres.

## **SCHEDULE 2**

### **(Shared use footway/cycle track for use by pedestrians and cyclists, pursuant to sections 65 of the Highways Act 1980)**

#### **Glasshouse Lane and Stansfield Grove, Kenilworth**

- (i) On the eastern side, from a point 69.5 metres north of the southern arm of the Oakley Road island (to be constructed), northwards for 196 metres
- (ii) On the western side, at its junction with Stansfield Grove, southward then south-westward for 139.5 metres
