1. BACKGROUND

1.1 The current advisory School Keep Clear outside those schools which are listed in the table below are proposed to become mandatory with the appropriate upright signage being installed to prohibit stopping on the markings during Monday-Friday between the hours of 8am-5pm. This will ensure the areas are kept clear of parked vehicles at times of heavy pedestrian usage, helping to avoid danger to persons or traffic using the road and prevent the likelihood of any such danger arising.

2. STATEMENT OF REASONS

- 2.1 Warwickshire's schools currently have unenforceable School Keep Clear markings which do not comply with the Traffic Signs Regulations and General Directions 2016 requirements. The proposed order seeks to implement enforceable school entrance markings and accompanying time plate signage detailing prohibition of stopping for vehicles during the restricted hours of 8am until 5pm, Monday to Friday. Locations will be assessed, and markings / signage introduced outside school entrances and school crossing patrol sites where appropriate.
- 2.2 The implementation of formal restrictions will enable effective enforcement of the markings, supporting the entrances of the schools and will prevent vehicles from parking

in the immediate vicinity, thus creating a safer environment for children and encouraging and facilitating pedestrian movements.

2.3 All school sites included in the Order as listed in the above table will receive ANPR mobile enforcement support.
