ON STREET PARKING PLACES AND RESIDENTS' PARKING)
(CONSOLIDATION) (VARIATION NO. 14) ORDER 2025**

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), the Traffic Management Act 2004, and of all other enabling powers, hereby make the following Order:-

1. The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
2. In Schedule 1 to the Principal Order, under the heading of Zone L1, delete "Trinity Street (nos. 1 to 9 only and nos. 150 to 167 only)" and replace with: -

"Trinity Street (nos. 1 to 9, nos. 150 to 167, no. 169 (Grooms Cottage) and no. 171 only".
3. In Schedule 1 to the Principal Order, under the heading of Zone L3, insert:-


"Warwick Place (The Flat at no. 7 only)"
4. In Schedule 1 to the Principal Order, under the heading of Zone W2, insert:-

"Spring Pool"
5. In Schedule 1 to the Principal Order, under the heading of Zone W6, delete "Antelope Gardens (numbers 1-16 inclusive)" and replace with:-

"Antelope Gardens (numbers 1-18 inclusive)"


6. This Order shall come into operation on the Second day of June Two thousand and twenty-five and may be cited as “The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents’ Parking) (Consolidation) (Variation No. 14) Order 2025”.
