This Order shall come into operation on the 30th day of June Two thousand and twenty five and may be cited as "The Warwickshire County Council (District of Stratford on Avon)(Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) (Variation G) Order 2025".


