THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF WARWICK) (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS, ON STREET PARKING PLACES & RESIDENTS' PARKING) (CONSOLIDATION) (VARIATION NO. 13) (PART) ORDER 2025

Warwickshire County Council has made the above-named Order in part, pursuant to the Road Traffic Regulation Act 1984, the effect of which is to vary the existing Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places & Residents' Parking) (Consolidation) Order 2017 (as varied) as described in Schedule 1 below. The proposals which have not been made are described in Schedule 2 below. The Order commences on 30 June 2025.
