This Order shall come into operation on the Thirtieth day of June Two thousand and twenty-five and may be cited as "The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents' Parking) (Consolidation) (Variation No. 13) (Part) Order 2025".
