THE WARWICKSHIRE COUNTY COUNCIL (D4691 COPPICE ROAD, D4696 MURCOTT ROAD EAST AND D4693 MOORHILL ROAD, WHITNASH, LEAMINGTON SPA) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2025

<u>WHEREAS</u> the Warwickshire County Council ("the Council") as traffic authority for D4691 Coppice Road, D4696 Murcott Road East and D4693 Moorhill Road, Whitnash, Leamington Spa is satisfied that traffic on the said roads should be restricted as indicated in the Schedule below by virtue of works proposed to be executed thereon.

<u>NOW THEREFORE</u> the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all enabling powers, hereby makes the following Order:

- 1. This order shall come into operation on 28 July 2025 and may be cited as "The Warwickshire County Council (D4691 Coppice Road, D4696 Murcott Road East and D4693 Moorhill Road, Whitnash, Leamington Spa) (Temporary Prohibition of Traffic) Order 2025".
- 2. No person shall cause or permit any vehicle other than an exempted vehicle to use D4691 Coppice Road, D4696 Murcott Road East and D4693 Moorhill Road, Whitnash, Leamington Spa as indicated in the Schedule below for a period of 18 months commencing on 28 July 2025, or until the said works are completed, whichever is the earlier.
- 3. In this Order exempted vehicle means any vehicle being used for or in connection with the said works.
- 4. The provisions of Article 2 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984.

Schedule:

Coppice Road - closed from Murcott Road East to Cypress Lane.

Murcott Road East - closed between the entrance of Whitnash Methodist Church car park and the entrance of Murcott Court car park.

Moorhill Road - closed from Coppice Road to Morse Road.
