(VARIATION NO. SKC01) ORDER 2025

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), the Traffic Management Act 2004, and of all other enabling powers, hereby make the following Order:-

PART I
CITATION AND INTERPRETATION

1. The Warwickshire County Council (District of Stratford) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
2. In Article 2 to the Principal Order, prior to the definition of "Specified Charge For Parking" insert:-

"School Keep Clear Area" means any area of carriageway marked thereon with a yellow zig-zag road marking complying with diagram 1027.1 (Schedule 7, Part 4, Item 10) of the 2016 Regulations"
3. In the Principal Order, after Article 8 insert:-

"8A Save as provided in Schedule 7, Part 6, Paragraph 4 of the 2016 Regulations, no person shall cause or permit a vehicle to stop on a length of road identified on the plans as a school keep clear area during the period of time identified on the plans in relation to that length of road."
4. In Schedule 2 to the Principal Order, insert Plan Title "GB81", followed by revision number "0".
5. In Schedule 2 to the Principal Order, after Plan Title "GN81", replace the revision number with revision number "1".
6. In Schedule 2 to the Principal Order, insert Plan Title "HC15", followed by revision number "0".
7. In Schedule 2 to the Principal Order, after Plan Title "HD15", replace the revision number with revision number "1".
8. In Schedule 2 to the Principal Order, insert Plan Title "HD75" followed by Revision Number "0".
9. In Schedule 2 to the Principal Order, insert Plan Title "HE75" followed by Revision Number "0".

10. In Schedule 2 to the Principal Order, after Plan Title “HK36”, replace the revision number with revision number “1”.
11. In Schedule 2 to the Principal Order, after Plan Title “HL36”, replace the revision number with revision number “2”.
12. In Schedule 2 to the Principal Order, insert Plan Title “HL59”, followed by revision number “0”.
13. In Schedule 2 to the Principal Order, after Plan Title “HM53”, replace the revision number with revision number “1”.
14. In Schedule 2 to the Principal Order, after Plan Title “HN53”, replace the revision number with revision number “2”.
15. In Schedule 2 to the Principal Order, after Plan Title “HQ36”, replace the revision number with revision number “3”.
16. In Schedule 2 to the Principal Order, insert Plan Title “IA16” followed by Revision Number “0”.
17. In the Principal Order, replace the plans attached thereto which are listed in column 1 of Schedule 1 below, with the plans attached to this Order and listed in column 2 of Schedule 1 below.
18. Attach the plans listed in Schedule 2 below and attached to this Order to the Principal Order.
19. This Order shall come into operation on the 18th day of August Two Thousand and Twenty-Five and may be cited as “The Warwickshire County Council (District of Stratford) (Civil Enforcement Area) (Waiting Restrictions, On-Street Parking Places and Residents’ Parking) (Consolidation) (Variation No. SKC01) Order 2025”.

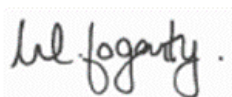
