# THE WARWICKSHIRE COUNTY COUNCIL (C43 HARBURY LANE, D3900 EARL RIVERS AVENUE & D4810 MACBETH APPROACH, HEATHCOTE, WARWICK) (TEMPORARY PROHIBITION OF TRAFFIC) ORDER 2025

<u>WHEREAS</u> the Warwickshire County Council ("the Council") as traffic authority for C43 Harbury Lane, D3900 Earl Rivers Avenue & D4810 Macbeth Approach, Heathcote, Warwick is satisfied that traffic on the said road should be restricted as indicated in the Schedule to this order by virtue of works proposed to be executed thereon.

NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all enabling powers, hereby makes the following Order:

- 1. This order shall come into operation on 28 September 2025 and may be cited as "The Warwickshire County Council (C43 Harbury Lane, D3900 Earl Rivers Avenue & D4810 Macbeth Approach, Heathcote, Warwick) (Temporary Prohibition of Traffic) Order 2025".
- 2. No person shall cause or permit any vehicle other than an exempted vehicle to use C43 Harbury Lane, D3900 Earl Rivers Avenue & D4810 Macbeth Approach, Heathcote, Warwick for a period of 18 months commencing on 28 September 2025, or until the said works are completed, whichever is the earlier.
- 3. In this Order exempted vehicle means any vehicle being used for or in connection with the said works.
- 4. The provisions of Article 2 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984

### SCHEDULE:

**Phase 1**: Harbury Lane from its junction with Vickers Way to Garrett Drive, Harbury Lane Roundabout, Earl Rivers Avenue from Harbury Lane roundabout to outside No. 22 Earl Rivers Avenue and Macbeth Approach from Harbury Lane roundabout to Collier Gardens -2 x Sundays 28th September and 5th October (0800 - 1700 hrs).

<u>Phase 2:</u> <u>Harbury Lane</u> from Harbury Lane Roundabout to Lionheart Avenue/Cicero Approach - 29th September to 3rd October (0900 - 1500 hrs).

<u>Phase 3</u>: <u>Harbury Lane</u> from Harbury Lane Roundabout to Tachbrook Road/Oakley Wood Road - 6th to 8th October (0900 - 1500 hrs).

<u>Phase 4:</u> Lionheart Avenue/Cicero Approach to Tachbrook Road/Oakley Wood Road - 9th October (0900 - 1500 hrs).
