#### **ROAD TRAFFIC REGULATION ACT 1984 & HIGHWAYS ACT 1980**

## PROPOSED TRAFFIC REGULATION ORDERS / FOOTWAY TO CYCLE TRACK CONVERSION / ROAD HUMPS / IN THE VICINITY OF WHEAT STREET, NUNEATON

Warwickshire County Council propose to make the below-named Orders pursuant to the Road Traffic Regulation Act 1984, the effect of such Orders would be as described (by approximate measurements) in Schedules 1 to 4 below:-

- (1) Warwickshire County Council (Wheat Street, Justice Walk and Bond Gate, Nuneaton) (20 mph Zone) 2025:
- (2) Warwickshire County Council (Bond Street, Nuneaton) (Prescribed Left Turn Manoeuvre) Order 2025;
- (3) Warwickshire County Council (Justice Walk and Wheat Street, Nuneaton) (One Way Traffic) (Variation No. 1) Order 2025;
- (4) Warwickshire County Council (Various Streets, Nuneaton) (One Way Traffic) (Variation No. 3) Order 2025; and
- (5) Warwickshire County Council (Church Street and Wheat Street, Nuneaton) (Prohibition of Driving) (Variation No. 1) Order 2025.

Warwickshire County Council further hereby proposes, pursuant to the Highways Act 1980, to:-

- (6) convert parts of existing footways, in those lengths of road described (by approximate measurements) in Schedule 5 below, into shared use footways/cycle tracks for use by pedestrians and cyclists;
- (7) convert parts of existing footways and carriageways, in those lengths of road described (by approximate measurements) in Schedule 6 below, into segregated use footways/cycle tracks for use by pedestrians and cyclists; and
- (8) to install road humps, in those lengths of road described (by approximate measurements) in Schedule 7 below.

### SCHEDULE 1 (Proposed 20 mph Zone)

- 1. Bond Gate, Nuneaton entire length
- 2. Justice Walk, Nuneaton entire length
- 3. Wheat Street, Nuneaton between A444 Vicarage Street and Bond Gate/Justice Walk

### SCHEDULE 2 (Proposed Left Turn Only Manoeuvre)

1. Bond Street, Nuneaton - left turn only manoeuvre onto the A444 Newtown Road from Bond Street

# SCHEDULE 3 (Proposed One Way Traffic Flow & Revocation of One Way Traffic Flow)

- 1. Wheat Street, Nuneaton one way traffic flow easterly between Justice Walk and Vicarage Street
- 2. Wheat Street, Nuneaton **revocation** of existing one way traffic flow westerly between Justice Walk & Bond Gate
- 3. Bond Gate, Nuneaton **revocation** of existing one way traffic flow northerly on the entire length.

## SCHEDULE 4 (Proposed Revocation of Prohibition of Driving)

 Wheat Street, Nuneaton – revocation of existing prohibition of driving restriction on the west side from its junction with Vicarage Street on its western side, heading towards Bond Gate for a distance of 10 metres.

### **SCHEDULE 5**

### (Proposed conversion of footways to shared use footways / cycle tracks)

- 1. Bond Gate, Nuneaton (south side) from Justice Walk, westwards for 16.3 metres
- 2. Justice Walk, Nuneaton (east side) from Wheat Street, southwards for 15.5 metres
- 3. Justice Walk, Nuneaton (west side) from Bond Gate, southwards for 10.9 metres
- 4. Vicarage Street, Nuneaton (east side) from Wheat Street, northwards for 16 metres
- 5. Vicarage Street, Nuneaton (west side) from 14.5 metres south of Leicester Road, southwards for 17.3 metres
- 6. Vicarage Street, Nuneaton (west side) from 80.6 metres south of Leicester Road, southwards to Wheat Street (47.2 metres)
- 7. Vicarage Street, Nuneaton (west side) from Wheat Street, southwards for 19.3 metres
- 8. Wheat Street, Nuneaton (south-east side) from Vicarage Street, eastwards for 18.2 metres
- 9. Wheat Street, Nuneaton (north-east side) from Vicarage Street, eastwards for 25 metres
- 10. Wheat Street, Nuneaton (south-west side) from Vicarage Street to Justice Walk

#### **SCHEDULE 6**

### (Proposed conversion of footways and carriageways to segregated use footways / cycle tracks)

- 1. Vicarage Street, Nuneaton (west side) from 31.8 metres south of Leicester Road, southwards for 44 metres
- 2. Vicarage Street, Nuneaton (west side) from 19.3 metres south of Wheat Street, southwards for 61.3 metres

# SCHEDULE 7 Proposed Road Humps (Raised Junction)

1. Wheat Street, Nuneaton - at its junctions with Justice Walk and Bond Gate and being 15.8m (width) x 26m (length) x 75mm (height) with an area of approximately 287m<sup>2.</sup>
