(40 MPH AND 50 MPH SPEED LIMIT) ORDER 2012

The Warwickshire County Council, in exercise of its powers under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other enabling powers and, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order: -

- Save as provided in Article 3, no person shall drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of road specified in Schedule 1 to this Order.
- 2. Save as provided in Article 3, no person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of road specified in Schedule 2 to this Order.
- 3. The provisions of Articles 1 and 2 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
- 4. This Order may be cited as "The Warwickshire County Council (A4177 Birmingham Road, A4141 Birmingham Road, B4439 Hockley Road, B4439 Old Warwick Road, Five Ways Road, Shaws Lane, Stoney Lane and The Green, Hatton) (40 mph and 50 mph Speed Limit) Order 2012" and shall come into operation on the Third day of December Two thousand and twelve.

# SCHEDULE 1 (40 mph speed limit)

#### 1. B4439 Hockley Road

From its junction with the A4177 Birmingham Road, in a westerly direction to a point 335 metres west of its junction with Dark Lane, a distance of 790 metres.

#### 2. B4439 Old Warwick Road, Rowington

From a point 150 metres west of its junction with Finwood Road, in a north-westerly direction to a point 895 metres south-east of its junction with Station Lane, a distance of 375 metres.

#### 3. The Green, Hatton

From its junction with the B4439 Hockley Road, in a northerly direction to a point 90 metres south of its junction with Starmer Place, a distance of 43 metres.

# SCHEDULE 2 (50 mph speed limit)

# 1. A4177 Birmingham Road

From its junction with the A46 roundabout, in a north-westerly direction to a point 342 east of its junction with Ugly Bridge Road, a distance of 897 metres.

# 2. A4141 Birmingham Road

From its junction with the A4177, in a northerly direction to a point 828 metres south of its junction with Heath Terrace, a distance of 115 metres.

#### 3. B4439 Hockley Road

From a point 335 metres west of its junction with Dark Lane, in a westerly direction to a point 1040 metres south-east of its junction with Mill Lane, Rowington, a distance of 3 kilometres.

#### 4. Five Ways Road

From its junction with the A4177, in a southerly direction to its junction with the B4439 Hockley Road, a distance of 2805 metres

# 5. Shaws Lane

From its junction with Five Ways Road, in an easterly direction to its junction with the A4177 Birmingham Road, a distance of 248 metres.

#### 6. Stoney Lane

From its junction with Five Ways Road, in a south-easterly direction to its junction with the A4177 Birmingham Road, a distance of 1290 metres.
