ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (STARMER PLACE AND THE GREEN, HATTON GREEN, WARWICK) (20 MPH SPEED LIMIT) ORDER 2025

1. STATEMENT OF REASONS

- **1.1** Following a request from Hatton Green Parish Council, Warwickshire County Council is proposing to introduce a 20-mph speed limit as shown on the plan attached (**Plan. No PTRO24/026/001**).
- 1.2 Warwickshire County Council is proposing to:
 - Introduce a 20-mph speed limit on the lengths of road described in Schedule 1 below which are currently 30mph by virtue of street lighting.
 - Vary the existing Order titled "The Warwickshire County Council (A4177 Birmingham Road, A4141 Birmingham Road, B4439 Hockley Road, B4439 Old Warwick Road, Five Ways Road, Shaws Lane, Stoney Lane and The Green, Hatton) (40 mph and 50 mph Speed Limit) Order 2012" to introduce a 40mph speed limit on the lengths of road described in Schedule 2 below
- **1.3** The scheme will involve the use of speed reducing traffic signs and road markings within a specific urban area located in the parish of Hatton Green.
- 1.4 As a result of further investigations conducted into the area requested for the speed reduction, results showed that the mean speeds have met the criteria for reducing the speed limit to 20mph without having to install traffic calming measures. In addition, consultations with the Traffic & Road Safety Team and Warwickshire Police concluded with a recommendation to introduce a 20mph speed limit on the roads detailed in Schedule 1 below.
- **1.5** The reduced speed limit will help improve the environment for vulnerable road users, such as wheelchair users, horse riders, pedestrians and pedal cyclists where there are no footpaths. The village has a church and a primary school which is used by residents and visitors to Hatton Green. Motorists will be travelling at a slower speed, and therefore more aware of safety issues when driving through the village.

2. SCHEDULE

SCHEDULE 1 (20mph Speed Limit)

D50870/1 - Starmer Place, Hatton Green

From its most northern point, in its entirety from its junction with The Green.

D50870/2 - Starmer Place, Hatton Green

From its most southerly point, in its entirety from its junction with The Green.

C93 The Green, Hatton Green

From a point 53 metres southwest of its junction with Birmingham Road to a point 43 metres northwest of its junction with Hockley Road, a total of 404 metres.

SCHEDULE 2 (40mph Speed Limit)

C93 The Green, Hatton Green

From its junction with Birmingham Road in a southwest direction for 53 metres.
