**ROAD TRAFFIC REGULATION ACT 1984**

**THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, HAMPTON ON THE  
HILL, WARWICK) (20 MPH SPEED LIMIT)  
ORDER 2025**

The Warwickshire County Council in exercise of its powers under section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, hereby make the following Order: -

1. Save as provided in Article 2 below, no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road described in the Schedule to this Order.
2. The Traffic Regulation Order titled "(Hampton Road and Old School Lane, Hampton on the Hill) (Restricted Roads) Order 2001" is hereby revoked in its entirety.
3. The provisions of Article 1 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
4. This Order may be cited as "The Warwickshire County Council (Various Roads, Hampton on the Hill, Warwick) (20 MPH Speed Limit) Order 2025" and shall come into operation on the                      day of                      Two Thousand and Twenty Five.

**SCHEDULE**

**D5307 Grove Croft, Hampton on the Hill**

In its entirety from its junction with Hampton Road.

**D6917 Grove Park, Hampton on the Hill**

From its junction with Hampton Road north-westward for 23 metres.

**D5309 Hampton Croft, Hampton on the Hill**

In its entirety from its junction with Old School Lane.

**C138/D5273 Hampton Road, Hampton on the Hill**

From a point 364 metres from its junction with Henley Road north-westward for 480 metres.

**C138 Old Budbrooke Road, Hampton on the Hill**

From its junction with Hampton Road in a northward direction for 54 metres.

**C138 Old School Lane, Hampton on the Hill**

For its entirety from its junction with Henley Road to its junction with Hampton Road.
