**THE WARWICKSHIRE COUNTY COUNCIL (DISTRICT OF WARWICK)

PLACES AND RESIDENTS' PARKING) (CONSOLIDATION)
(VARIATION Q) ORDER 2025**

The Warwickshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by sections 1(1), 2(1) to (3), 4(2), 19, 32, 35, 45, 46, 47, 49, 53 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the 1984 Act"), the Traffic Management Act 2004, and of all other enabling powers, hereby make the following Order:-

1. The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) Order 2017 (which said Order of 2017 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
2. In Schedule 2 to the Principal Order, after Plan Title GA54, replace the Revision Number "1" with the Revision Number "2".
3. In the Principal Order, replace the plan annexed thereto and numbered "GA54 Revision No. 1" with the plan annexed hereto and numbered "GA54 Revision No. 2"
4. This Order shall come into operation on the First day of October Two thousand and twenty-five and may be cited as "The Warwickshire County Council (District of Warwick) (Civil Enforcement Area) (Waiting Restrictions, On Street Parking Places and Residents' Parking) (Consolidation) (Variation Q) Order 2025".


