ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, ANSLEY) (50 MPH & 30 MPH SPEED LIMIT AND DE-RESTRICTION) ORDER 2025

Warwickshire County Council proposes to make the above-named Order under the Road Traffic Regulation Act 1984 the effect of which will revoke the following orders in their entirety:

- The Warwickshire County Council (C12 Tunnel Road, Galley Common) (50mph speed limit) Order 2012;
- The Warwickshire County Council (Birmingham Road, Ansley) (30mph Speed Limit) Order 2022; and
- The Warwickshire County Council (Various Roads, Ansley) (Restricted Road, Derestriction & 30 mph Speed Limit) Order 2010.

The effect of the new proposed order will:

- reduce the length of the existing 50mph speed limit on the length of road mentioned in Schedule 1 below, which will be replaced by a 30mph speed limit imposed by virtue of a system of streetlighting to be installed; and
- impose a 30mph limit in Schedule 2 by way of Order
- de-restrict the road (currently 30mph) as described in Schedule 3 and become National Speed Limit
- revoke the above Orders for administrative reasons only and the roads in Schedule 4 will remain 30mph by virtue of a system of streetlighting.

SCHEDULE 1 50mph Speed Limit

C12 Tunnel Road, Ansley

From a point 290 metres northeast of its junction with the B4112 Birmingham Road / Ansley Road, north-eastwards to a point 46 metres southwest of its junction with D6789 Haunchwood Park Drive, a distance of 713 metres.

SCHEDULE 2 30mph Speed Limit

C12 Arley Lane, Ansley

From a point 83 metres south of its junction with the B4112 Birmingham Road / Ansley Road, southwards for a distance of 67 metres.

SCHEDULE 3 De-Restricted Road to become NSL

B4112 Birmingham Road / Ansley Road, Ansley

From a point 32 metres southeast of the centre line of C126 Ansley Lane, north-westwards for a distance of 130 metres.

SCHEDULE 4 30mph by Virtue of System of Street Lighting (Restricted Road)

C12 Arley Lane, Arley

From its junction with the B4112 Birmingham Road / Ansley Road, southwards for a distance of 83 metres.

C12 Tunnel Road, Ansley

From its junction with the B4112 Birmingham Road / Ansley Road, north-eastwards for a distance of 290 metres.

B4112 Birmingham Road / Ansley Road, Ansley

From a point 75 metres southeast of the centre of the roundabout at its junction with C12 Arley Lane and C12 Tunnel Road, north-westwards to a point 32 metres southeast of the centre line of Ansley Lane, a distance of approximately 1333 metres.
