**ROAD TRAFFIC REGULATION ACT 1984**

**THE WARWICKSHIRE COUNTY COUNCIL (WATHEN ROAD AREA, WARWICK)**  
**(20 MPH SPEED LIMIT) ORDER 2025**

The Warwickshire County Council in exercise of its powers under section 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, hereby make the following Order: -

1. Save as provided in Article 2 below, no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road described in the Schedule to this Order.
2. The provisions of Article 1 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
3. This Order may be cited as "(Wathen Road Area, Warwick) (20 Mph Speed Limit) Order 2025" and shall come into operation on the 20<sup>th</sup> day of October Two Thousand and Twenty-Five.

**SCHEDULE**

**Wedgnock Green, Warwick.**

For its entire length between its junctions with Millers Road, Oken Road, Peel Road and Newburgh Crescent.

**Deerpark Drive, Warwick.**

For its entire length from its junctions with Cape Road/Newburgh Crescent to Wedgnock Green.

**Newburgh Crescent, Warwick**

For its entire length from its junction with Deerpark Drive to Wedgnock Green.

**Oken Road, Warwick**

For its entire length from its junction with Cape Road to Wedgnock Green.

**Peel Road, Warwick**

For its entire length from its junction with Wedgnock Green to Wathen Road.

**Tatnall Grove, Warwick**

For its entire length from its junction with Peel Road.

**Lyttleton Road, Warwick**

For its entire length from its junction with Millers Road to Wathen Road.

**Percy Road, Warwick**

For its entire length from its junction with Peel Road to Lyttleton Road.

**Wathen Road, Warwick**

For its entire length from its junction with Millers Road to Trueman Close/Vine Lane.

**Trueman Close, Warwick**

For its entire length from its junction with Wathen Road and Vine Lane.

**School Lane, Warwick**

For its entire length from its junction with Trueman Close.

**Vine Lane, Warwick**

For its entire length from its junction with Wathen Road/Trueman Close to Lakin Court.

**Lakin Court, Warwick**

For its entire length from its junction with Paradise Street.

**Paradise Street, Warwick**

For its entire length from its junction with Woodville Road/Roe Close to Lakin Road.

**Sharpe Close, Warwick**

For its entire length from its junction with Woodville Road.

**Roe Close, Warwick**

For its entire length from its junction with Woodville Road/Paradise Street.

**Packmore Street, Warwick**

For its entire length from its junction with Lakin Road to Roe Close.

**Woodcote Road, Warwick**

For its entire length from its junction with Lakin Road.

**Lakin Road, Warwick**

For its entire length from its junction with Guy's Cross Park Road to A429 Coventry Road.

**Remburn Gardens, Warwick**

For its entire length from its junction with Lakin Road.

**Green Lane, Warwick**

For its entire length from its junction with Lakin Road.

**Woodville Road**

For its entire length from its junction with Vine Lane to Paradise Street/Roe Close.


