ROAD TRAFFIC REGULATION ACT 1984

THE WARWICKSHIRE COUNTY COUNCIL (VARIOUS ROADS, ANSLEY) (50 MPH & 30 MPH SPEED LIMIT AND DE-RESTRICTION) ORDER 2026

The Warwickshire County Council in exercise of its powers under section 82 and 84 of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, hereby make the following Order: -

1. Save as provided in Article 2 below, no person shall drive any motor vehicle at a speed exceeding 50 miles per hour on the length of road described in Schedule 1 to this Order.
2. Save as provided in Article 2 below, no person shall drive any motor vehicle at a speed exceeding 30 miles per hour on the length of road described in Schedule 2 to this Order.
3. The length of road specified in Schedule 3 to this Order shall cease to be a Restricted Road for the purposes of Section 81 of the Act,
4. The following orders are to be revoked in their entirety: The Warwickshire County Council (C12 Tunnel Road, Galley Common) (50mph speed limit) Order 2012; The Warwickshire County Council (Birmingham Road, Ansley) (30mph Speed Limit) Order 2022; and The Warwickshire County Council (Various Roads, Ansley) (Restricted Road, De-restriction & 30 Mph Speed Limit) Order 2010.
5. The provisions of Article 1 and Article 2 of this Order shall not apply to a vehicle falling within regulation 3(4) of The Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations 2011 when such a vehicle is used in accordance with regulation 3(5) of those Regulations.
6. This Order may be cited as "The Warwickshire County Council (Various Roads, Ansley (50MPH & 30MPH Speed Limit and De-Restriction) Order 2025" and shall come into operation on the 2nd day of February Two Thousand and Twenty Six.

SCHEDULE 1
50mph Speed Limit

Tunnel Road, Ansley

From a point 290 metres northeast of its junction with the B4112 Birmingham Road / Ansley Road, north-eastwards to a point 46 metres southwest of its junction with D6789 Haunchwood Park Drive, a distance of 713 metres.

SCHEDULE 2
30mph Speed Limit

C12 Arley Lane, Ansley

From a point 83 metres south of its junction with the B4112 Birmingham Road / Ansley Road, southwards for a distance of 67 metres.

SCHEDULE 3
De-Restricted Road to become NSL

B4112 Birmingham Road / Ansley Road, Ansley

From a point 32 metres southeast of the centre line of C126 Ansley Lane, north-westwards for a distance of 130 metres.
