**ROAD TRAFFIC REGULATION ACT 1984, SECTION 14(1)**

**THE WARWICKSHIRE COUNTY COUNCIL (A426 LEICESTER ROAD & D6971 CENTRAL PARK DRIVE, RUGBY) (TEMPORARY PROHIBITION OF TRAFFIC) AND (A426 LEICESTER ROAD, RUGBY) (TEMPORARY 30MPH SPEED RESTRICTION) ORDER 2026**

WHEREAS the Warwickshire County Council ("the Council") as traffic authority for A426 Leicester Road & D6971 Central Park Drive, Rugby is satisfied that traffic on the said roads should be restricted by virtue of works proposed to be executed thereon.

NOW THEREFORE the Council in exercise of its powers under Section 14(1) of the Road Traffic Regulation Act 1984 and all enabling powers, hereby makes the following Order:

1. This order shall come into operation on 15 February 2026 and may be cited as "The Warwickshire County Council (A426 Leicester Road & D6971 Central Park Drive, Rugby) (Temporary Prohibition of Traffic) and (A426 Leicester Road, Rugby) (Temporary 30 mph Speed Restriction) Order 2026".
2. No person shall cause or permit any vehicle other than an exempted vehicle to use A426 Leicester Road, Rugby northbound and southbound carriageways, including all roundabouts, closed from M6 junction 1 to D2571 Junction One Retail Park and D6971 ,Central Park Drive, Rugby from its junction with the A426 Leicester Road to Castle Mound Way/Coton Park Drive, including roundabout joining Castle Mound Way and Coton Park Drive, for a period of 18 months commencing on 15 February 2026, or until the said works are completed, whichever is the earlier.
3. In this Order exempted vehicle means any vehicle being used for or in connection with the said works.
4. No person shall drive any motor vehicle at a speed exceeding 30 miles per hour on A426 Leicester Road, Rugby northbound and southbound carriageways, including all roundabouts, from M6 junction 1 to D2571 Junction One Retail Park for a period of 18 months commencing on 15 February 2026, or until the said works are completed, whichever is the earlier.
5. The provisions of Articles 2 and 4 above shall apply only at such times and to such extent as shall be indicated by traffic signs, as authorised by Section 64 of the said Act of 1984.
