**THE WARWICKSHIRE COUNTY COUNCIL (COMBROOK, KINETON, PILLERTON PRIORS,
RATLEY AREA) (PROHIBITION OF COMMERCIAL VEHICLES OVER 7.5 TONNES)
(VARIATION NO. 2)
ORDER 2026**

The Warwickshire County Council in exercise of its powers under sections 1, 2 and 4 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act"), and of all other enabling powers, hereby make the following Order:

1. The Warwickshire County Council (Combrook, Kineton, Pillerton Priors, Ratley Area) (Prohibition of Commercial Vehicles Over 7.5 Tonnes) Order 1991 (which said Order of 1991 as varied is hereinafter referred to as 'the Principal Order') is hereby further varied in the manner and to the extent hereinafter provided.
2. In the Schedule 2 to the Principal Order, delete item 12 and replace with:-

"12. B4086 Edgehill Lane

From its junction with Camp Lane for a distance of 1206 metres in a south-westerly direction."
3. In the Schedule 2 to the Principal Order, delete item 14 in its entirety.
4. In the Schedule 2 to the Principal Order, insert the following text as item 15:-

"15. Featherbow Lane

In its entirety from its junction with High Street."
5. In the Schedule 2 to the Principal Order, insert the following text as item 16:-

"16. High Street

In its entirety from its junction with Old Road to its junction with Featherbow Lane."
6. In the Schedule 2 to the Principal Order, insert the following text as item 17:-

"17. Chapel Lane

In its entirety from its junction with Townhill to its junction with High Street."
7. In the Schedule 2 to the Principal Order, insert the following text as item 18:-

"18. Townhill

In its entirety from its junction with Old Road/High Street to its junction with Chapel Lane."

8. In the Schedule 2 to the Principal Order, insert the following text as item 19:-

“19. Batchelors Lane

In its entirety from its junction with Old Road.”

9. In the Schedule 2 to the Principal Order, insert the following text as item 20:-

“20. New Road

In its entirety from its junction with Old Road.”

10. In the Schedule 2 to the Principal Order, insert the following text as item 21:-

“21. Grange Close

In its entirety from its junction with Old Road.”

4. This Order shall come into operation on the 16th day of March Two thousand and Twenty Six and may be cited as “The Warwickshire County Council (Combrook, Kineton, Pillerton Priors, Ratley Area) (Prohibition of Commercial Vehicles Over 7.5 Tonnes) (Variation No. 2) Order 2026”.


